#### 1. Authorization.

The above-named Client (hereinafter referred to as "Client") is engaging Ministry Web Designing (MinistryWebDesigning.Com) as an independent contractor for the specific purpose of designing a World Wide Web site, herein after referred to as "Web Design Project", to be published on Ministry Web Designing Hosting account on an Internet Service Provider (ISP)/Web Presence Provider (WPP) computer, herein after referring to as "Hosting Service". The Client hereby authorizes Ministry Web Designing (MinistryWebDesigning.Com) to access this account and authorizes the Hosting Service to provide Ministry Web Designing (MinistryWebDesigning.Com) and its designer, Ministry Web Designing (MinistryWebDesigning.Com), with "full access" to the Client's account, and any other programs needed for this Web Design Project that are included as part of the Client's service agreement/level. The Client also authorizes Ministry Web Designing (MinistryWebDesigning.Com) to submit the completed Web Design Project to major Web Search Engines (Google).

### 2. Development.

This Web Design Project will be developed using Microsoft® Expression, Theme Builder. Bootstrap, Adobe® Photoshop and other web software. Format: WordPress®, HTML5, CSS, XML, PHP, MySQL, JavaScript.

#### 5. Web Site Maintenance.

In accordance with the terms of this agreement, your website will get congratulatory minor maintenance updates to its pages for the duration of its existence. The client is responsible for making any modifications to the content that appears on a web page, except for some non-editable portions that are protected by hard code. Maintaining and servicing all security and upgrades for web software as well as any default functionality of the website are going to be the responsibility of Ministry Web Designing.

### 6. Completion Date.

Ministry Web Designing (MinistryWebDesigning.Com) and the Client must collaborate to timely complete the Web Design Project. We agree to complete the Web Design Project no later than 30 days after receiving all relevant materials from the client.

## 7. Project Delivery.

The final web site design project will be published to the hosting service upon receipt of full payment. The Client understands that Ministry Web Designing (MinistryWebDesigning.Com) provides hosting services in connection with this Web Design Project. Hosting services will be provided by www.VisualVergeHosting.com. The Client allows Ministry Web Designing (MinistryWebDesigning.Com) full access to the Client's account via FTP (File Transfer Protocol). Ministry Web Designing is fully liable for all hosting service and product renewal fees for as long as the client's website developed by Ministry Web Designing is active

(monthly subscription must be current see section 12 paragraph 2). If the client cancels service with Ministry Web Designing, the client will be fully responsible for all hosting and domain fees thereafter. Once cancellation is executed, no other services, licenses, or software priority rights would be accessible for use.

#### 8. Electronic Commerce Laws.

## 10. Platform & Soft Configuration

Due to software license and priority rights, all websites will be hosted on the Visual Verge Hosting platform (www.visualvergehosting.com). Ministry Web Designing is a DBA of Visual Verge, LLC, which can be found at www.visverge.com. All accounts associated with the client's website, such as Hosting Space, Domain Name, and SiteLock, are registered and owned by the client.

All content created by Ministry Web Designing for the client, including images, banners, and text, belongs solely to the client. No software will be transferred to the client upon cancellation (Software licenses and priority rights of Visual Verge, LLC).

### 11. Payments.

Payments must be made promptly based on the terms of this Web Site Design Project. Payment is to be made prior to executing the Web Design Project. In the event that collection is necessary, the Client agrees to pay all fees (including attorney's fees and court costs) associated with that proceeding. This agreement becomes effective only when signed by Ministry Web Designing (MinistryWebDesigning.Com). Regardless of the place of signing of this agreement, the Client agrees that for purposes of venue, this agreement was entered into Bexar County, San Antonio, Texas, and any dispute will be litigated or arbitrated in Bexar County, San Antonio, Texas, and the Client hereby consents to the personal jurisdiction of the San Antonio, Texas State Courts. Notwithstanding any prices listed in literature or on Web pages, the Client, and Ministry Web Designing (MinistryWebDesigning.Com) agree that the services described in this agreement, and the Package Price, shall be completed for \$99.97. ### 15. Legal Notice.

Notwithstanding anything to the contrary contained in this agreement, neither Ministry Web Designing (MinistryWebDesigning.Com) nor any of its employees or agents warrants that the functions contained in the Web Design Project will be uninterrupted or error-free. The Client assumes the whole risk for the Web Design Project's content and client-caused failures, excluding unavoidable occurrences. In no event will Ministry Web Designing (MinistryWebDesigning.Com) be liable to the Client or any third party for any damages, including, but not limited to, service interruptions caused by Acts of God, the Hosting Service or any other circumstances beyond our reasonable control, any lost profits, lost savings or other incidental, consequential, punitive, or special damages arising out of the operation of or inability to operate this Web Design Project, failure of any service provider, of any telecommunications carrier, of the Internet backbone, of any Internet servers, you or your site visitor's computer or Internet software, even if Ministry Web Designing (MinistryWebDesigning.Com) has been advised of the possibility of such damages.
